- 2. OEM Motherboard with OEM logo printed on the same. No stickers allowed.
- 3. Wired keyboard and mouse (same make as OEM of desktop)
- 4. OEM ISO 9001, 14001, 27001 and 20001
- 5. Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 2 years residual market life i.e. the offered product shall not be declared end-of life by the OEM before this period.
- 6. Malicious code & warranty certificate
- 7. Bill of materials with part code on OEM letterhead to be part of bid submission signed by a person having Power of Attorney/Board Resolution in OEM



- 8. 3 Years Comprehensive warranty. OEM to submit undertaking that product is Not end of sale as on the date of bidding and that the product will be supported for the entire period of warranty
- 9. OEM should have minimum of 5 service centres at the time of bidding. Documentary evidence of such service centres to be part of bid submission.
- 10. Technical compliance of the offered product to be submitted on OEM letter head and signed a person having power of attorney/board resolution in OEM which also should be submitted in the bid.
- 11. The Supplier shall have its registered Office in Assam. Trade license from Local Authority must be submitted.
- 12. Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers will match and verify the Data Sheet with the product specifications offered.
- 13. Bidder of the quoted product should give a declaration that they have not been black listed by ant Govt./PSU/Defence/Financial Institute in the past 10 Years

Terms and Conditions:

- 1. All technical documents along with the supporting documents in conformity with the terms and conditions are to be placed in a sealed envelope with Price quotations for various components/System clearly indicating the amount including various tax components etc.
- 2. The sealed envelope is required to be placed inside a comparatively bigger sealed envelope clearly super-scribed on the top of the same as "Supply and Installation of Desktop Workstation Under DST-INSPIRE Faculty Fellowship Research Grant, in Bhattadev University, Bajali. NIB No. BU/E&A Sec/NIB/2024/4022 DATED 12/06/2024". The name and address of the bidder along with valid contact number(s) must be mentioned on each of the envelopes. The bigger sealed envelope addressed to "The Registrar, Bhattadev University, Bajali, Pathsala, PIN-781325, Assam" must be submitted during office hours in the Drop-Box arranged for the purpose or sent by post on or before 4.00 PM of 18/06/2024. Tender sent by post must be reach by the above time and date. For late delivery by postal or any other authentic mailing services, the institute shall not be responsible.
- 3. No separate tender paper will be issued from the office; one should only download the List of Equipments along with Specifications from the university website: https://bhattadevuniversity.ac.in
- 4. The rates should be quoted in Indian Rupee. GST (CGST, SGST, IGST), admissible duties, rates and other taxes, if any, all of which shall be shown separately. Insurance, wages of manpower, and other incidental expenses must be borne by the selected bidder themselves. The items must be delivered to the University free of cost.
- 5. The total number of each type of equipment to be purchased will depend on fund availability; and, the university may decide not to purchase any given type of equipment without giving any reason.



- 6. Applicable levies, surcharge and discounts should be clearly indicated item-wise.
- 7. Quoted rates should be valid at least for a period of 6 months.
- 8. The rates should be quoted along with supporting documents of specifications and technical features.
- 9. Warranty/ Guarantee period should be specifically mentioned in the quotation against each item
- 10. Details of availability of after sales support and spare parts will have to be furnished. After sales support, directly from manufacturer will be preferred.
- 11.Rates must be quoted item wise. PAN/GSTN wherever applicable, must be mentioned.
- 12. The application must be accompanied by a compulsory non-refundable bid processing fee of `1000/-. The bid processing fees must be deposit through SBI Collect. The Earnest Money Deposit (EMD) of Rs. 10,000/- (Rupees ten thousand only) (Refundable) must be deposit through SBI Collect. (for depositing EMD go to https://www.onlinesbi.sbi/, click on SBI collect-Select Category as Educational Institutions- Search Educational Institute as Bhattadev University Bajali-Select Payment Category as Earnest Money Deposit(EMD)-Rs. 10000/---then filled in all the details—then click next—Click Next—Select payment type—then make payment) failing which the Tender will be rejected.

Provided that any concession in bid security deposit as may be notified by the State Government from time to time for encouraging local industries or small business, micro and small enterprises located in and operating from the State, recognized start-ups located in and operating from the State, individual bidders belonging to different reserved categories of the State, individual physically challenged bidders of appropriate levels of disability, and women entrepreneurs etc., shall be allowed accordingly on production of the relevant certificates from the competent authorities.

For successful bidder, EMD will be converted to security Deposit for the entire warranty period and will be retained with Bhattadev University.

- 14. Lowest rate may or may not be the sole selection criterion for award of the supply order. However, the negotiations, if necessary, to be made by Bhattadev University with the Ll bidder (s) may be held for finalizing the order.
- 15. Manufacturer's Authorization Form from original equipment manufacturer (OEM) must be submitted.
- 16. All other terms and conditions will be as per the Bhattadev University rules and regulations.
- 17. Bhattadev University reserves the right of modifications, cancellations and decisions in regard to the entire process.
